Nature / Type of Organisation and Services Provided:

Tayyibah Girls' School is an all-girl independent Islamic primary and secondary school for girls aged 4-16. It is located in the London Borough of Hackney. We aim to provide a safe and caring environment, to the achieve the highest potential of all our pupils.

Our commitment to safeguarding children:

At Tayyibah Girls School we are committed to safeguarding and promoting the welfare of children and expect all staff to share this commitment.

Tayyibah Girls School will work together with other agencies to ensure there are adequate arrangements within the school to identify and support pupils at risk of harm.

There will always be a designated safeguarding lead (DSL) and deputy safeguarding lead (DDSL) available on site or reachable by phone, ensure they have the necessary training manage safeguarding concerns.

Risk that children might face (1)

Risk that signs of abuse, neglect or other concerns might not be noted by staff.

How are we mitigating this risk? (1)

School leadership prioritises safeguarding. All adults in the school have regular KCSIE training. All new staff have safeguarding training as part of their induction.

Child on child abuse or any form of bullying between children.

Mental health issues, such as anxiety stress, specifically around school issues.

Pastoral support offered to pupils Targeted support and appropriate referral Curriculum teaching and learning to promote resilience and support Tutorials to help pupils develop like skills As part of RSE curriculum, all pupils are taught about mental health

Children will not know who to approach or will not seek help when they need it.

Remind pupils who to approach in case of concerns

Reminders regularly given in tutorial lessons
